Notes on Fee Comparison

Telephone calls were made to Garfield County (Amy, Camille); Wayne County (Felicia Snow, Colleen); Escalante (Nancy). Calls to other towns were attempted but did not return message. Fees for various county and municipal websites were located via web search. The listed communities include smaller municipalities and southern Utah tourist-impacted towns but the survey was opportunistic, not systematic.

JMV work

In addition to the Boulder Town fee the applicant pays the Garfield County Building Department. County permit fees are based on a sliding scale depending on the construction project valuation. Examples: \$60 minimum, \$1027 for a \$100,000 project, \$3440 for a \$500,000 project.
